# Why Kepler Vision Technologies needs data

### **How long Kepler Vision Technologies stores data**

Kepler Vision Technologies will not retain your personal data for longer than is strictly necessary to fulfil the purposes for which your data is collected. We use the following retention periods for the aforementioned (categories of) personal data: 2 years.

### Special and/or sensitive personal data we process

possible, but within four weeks.
